To the President and Committee
of the V. D. Land Total Abstinence Society.

It will be remembered,

by most of you that some years ago I became,
the purchaser of the premises in Bathurst St.
now used as a Temperance Hall, and that

in transferring my right ^{thereto} ~~to the property~~ I stipulated
that a certain amount should be left in my hand
as a set off against the donations & contributions

of myself & others towards the purchase of the property,

from which, ^{from which, when compelled to} ~~separately~~ from the Hobart Town T. Abst.
Soc'y., we ceased to derive any benefit from.

This sum I intended should form the nucleus of
a Building Fund for the future use & appropriation
of the V. D. Land ^{Total Abstinence} Society, which was originally

composed of seceders from the H. Town T. A. Society,
& with this ^{object in} view I deposited the amount viz.

Thirty-eight pounds 7/0 (£ 38.7.0) in the H. T.
Savings Bank, under the head "Temperance Hall

Trust Fund", where it still remains, & with
addition of interest will now amount to upwards

of £ 44. My object in bringing these facts under
your notice ^{officially} is to suggest the propriety of your nomi-

nating two or more Trustees, on behalf of the
V. D. Land T. Abst. Soc'y., to whose names the money

is to be paid.
