Professor of Economics 1930-35, lecturer from 1925 Vice-Chancellor 1949-1957.

Torleiv Hytten (1890-1980) C.M.G. MA. was born in Norway and emigrated to Australia in 1910 and after working in various jobs, including journalism (1920-26) he was appointed lecturer in economics at the University of Tasmania in 1925. He was also Director of Tutorial Classes 1928-32. He was economic adviser to the Tasmanian Government 1929-35, economic adviser to the Bank of N.S.W. 1935-49, delegate to the 16th Assembly of the League of Nations 1935, Chairman of the Australian National Committee of the International Chamber of Commerce 1949. He also served on other Government Committees and advised on other matters including the Tasmanian Commonwealth Grants, Tasmanian State Employment Council, Tasmanian Railways and Queensland transport problems. He received the C.M.G in 1953, Knight Order of St. Olav (Norway) in 1951, Chev. Order of the Crown of Belgium on 1957.

PARLIAMENTARY DEADLOCKS COMMITTEE

In 1948 a joint committee of both Tasmanian Houses of Parliament was appointed to inquire into the electoral system and the possibility of avoiding 2 parties gaining an equal number of seats at a genereal election. Professor L.F. Giblin, who had made suggestions on parliamentary representation in 1915, was one of the first to give evidence. In 1951 the Governor appointed Professor Lyndhurst Falkiner Giblin, with Professor Torlein Hytten and Harold James Exley, to be a Board of Enquiry into measures to overcome the likelihood of Partliamentary deadlocks. According to Professor Hytten, the Chairman, Professor Giblin was "very helpful in sorting our ideas at the beginning " but when it came to hearing evidence he was too sick and had to withdraw from the committee, leaving Professor Hytten and Mr Exley to carry on.
